Call for Artists: Small Works

On-site screening (with online pre-registration) of actual artwork.

Entry Regulations:

- Exhibition is open to all current and paid PITTSBURGH **Society of Artists** members.
- Please update your membership at www.pittsburghsocietyofartists.org. It is the responsibility of the artist to make sure membership is current.
- Online registration is required. Any works not registered through the online system will NOT be accepted, NO exceptions.
- Artists may enter up to two (2) pieces. **This is a small works show.**
- Each piece will be considered eligible for inclusion in the show.
- Only 2D work or sculpture suitable for wall display (gallery does not have pedestals).
- Freestanding sculptures and or installations will NOT be accepted.
- Diptych and Triptych Pieces will not be accepted.
- **The longest dimension (including frame) for any 2D piece may be no more than 12 inches on its longest side. The longest dimension of any 3D piece may also not exceed 12 inches.**
- All dimensions of work will be verified at the time of drop off, pieces exceeding these dimensional requirements will NOT be accepted. NO EXCEPTIONS.
- All 2D work must be presentation ready.
- All 2D work must be suitably wired for hanging, work must be rigidly supported or framed. Wall hung sculptures must have positive hanging devices affixed to the piece.
- All work must be for sale. Work submitted without pricing will NOT be accepted for the jurors consideration.
- Artists are responsible to transport work to and from the gallery.
- All submitted work must be hand delivered to **Ketchup City Creative** at 612 Main Street, Pittsburgh PA 15215 for the jury process by Friday April 5, 2019 5:00 to 7:00 pm or Saturday April 6, 2019 9:00 am to 12:00pm. No submissions will be accepted past 12:00 pm on April 6, 2019. Please refer to calendar.
- Artists not selected for the exhibit will be notified on Saturday April 6, 2019 after 4:00 pm or earlier dependent on the duration of the jury process. Artists **MUST** pick up unselected work on Sunday April 7, 2019 10:00 to 4:00 pm.
- All works must have a tag attached to the back of your work upon delivery.

Juror: John Eastman

John Eastman is an abstract painter, wood sculpture-furniture designer, and mixed media installation artist. A native of South Western Pennsylvania, Eastman frequents multiple areas of Europe and New Mexico. He started as a self-taught abstract painter of large works in 2002 and began to exhibit in galleries and museums within three years, adding wood sculpture and furniture to his body of work in 2010. In the past year, his artwork has evolved into designing and building small buildings wrapped in corrugated sheet metal and painted framed wood, with art installations residing within, creating an exterior artwork structure, with interior art. The structures blend into the industrial past of Western Pennsylvania, while reflecting the current neighborhood surroundings of nature, buildings, lights, and streets. Eastman's artwork is often the result of long term concept planning and sketch-study development, resulting in a series.

He currently works in several studios in Pittsburgh Pennsylvania and is building a studio in Madrid New Mexico. Visit the EASTMANTRIBE brick & mortar store in Regent Square (Tuesday-Saturday 11-6 pm). www.eastmantribe.com
